

TERMS OF SERVICE

1. Introduction This Service Agreement ("Agreement") governs the relationship of GetASeedbox.com (the "Service Provider"), its systems and resources (the "Service"), and any entity that is explicitly granted use of the Service (the "Subscriber").

2. Acceptance and Assignment The Subscriber shall indicate acceptance of this Agreement in the course of submitting an order to the Service Provider through the Service Provider's electronic order form or by accessing the Service. The Service Provider shall indicate acceptance of this Agreement by sending confirmation of the order to the Subscriber by electronic mail. The Subscriber may not assign rights or delegate duties assumed by acceptance of this Agreement without the prior written consent of the Service Provider, and any attempted assignment or delegation without such consent shall be void. 3. Services The Service Provider shall provide access to the Services paid for by the Subscriber expressly for the use of the Subscriber, to include maintenance of the underlying hardware and network infrastructure necessary to connect the Service to the Internet and a password to support authentication while using the Service. The Subscriber shall not obtain any right or title in any equipment or software belonging to the Service Provider or any third parties whose equipment the Service Provider may utilize to provide the Service. During the term of this Agreement, and conditioned upon full payment of fees, the Service Provider grants to the Subscriber a non-exclusive, non-transferable license to access and use the Service solely in accordance with this Agreement and the guidelines set forth in the Acceptable Use Policy.

4. Server Suspension and Privacy

* a. The Service Provider makes it its priority not to access a clients data without his knowledge and/or permission, but it reserves the right to perform such actions if: i. Ordered so by a court or law enforcement institution ii. Ordered to do so by OVH

* b. Any abuse information sent to the Service Provider about clients will be forwarded to OVH

* c. The Service Provider takes no responsibility for what the Subscriber does with his server, therefore the Service Provider won't accept any responsibility for what the end user might do.

* d. The Service Provider will suspend any servers if:

i. The payment for the renewal of the server has not been received,

ii. The Subscriber has defied this Terms of Service Agreement

iii. The Service Provider is ordered to do so by a court or a law enforcement agency

iv. The Service Provider is ordered to do so by OVH

v. The Subscriber uploads, stores, displays, transmits, advertise or otherwise make available child pornography.

* e. In case of server suspension by OVH or by a court or law enforcement institution no refund will be issued to the Subscriber.

5. Prohibited Uses

* a. The use of the Services to store, post, display, transmit, advertise or otherwise make available child pornography is prohibited. GetASeedbox.com is required by law to, and will, notify National Center for Missing & Exploited Children's CyberTipline and other law enforcement agencies when it becomes aware of the presence of child pornography on, or being transmitted through, the Services.

* b. No Subscriber may utilize the Services to provide, sell or offer to sell the following: controlled substances; illegal drugs and drug contraband; weapons; pirated materials; instructions on making, assembling or obtaining illegal goods or weapons to attack others; information used to violate the copyright(s) of, violate the trademark(s) of or to destroy others' intellectual property or information; information used to illegally harm any people or animals; pornography, nudity, sexual products, programs or services; escort services or other content deemed adult related.

* c. Profanity or profane subject matter hosted by us are prohibited.

* d. Subscribers may not post or disclose any personal or private information about or images of children or any third party without the consent of said party (or a parent's consent in the case of a minor).

* e. "Hacking" and related activities are prohibited. "Hacking" includes, but is not limited to, the following activities: illegally or without authorization, accessing computers, accounts or networks, penetrating or attempting to penetrate security measures, port scans, stealth scans, and other activities designed to assist in hacking.

* f. The use of the Services to engage in any activity that is determined by GetASeedbox.Com, in its sole and absolute discretion, to be illegal is prohibited. Such illegal activities include, but are not limited to, storing, posting, displaying, transmitting or otherwise making available ponzi or pyramid schemes, fraudulently charging credit cards or displaying credit card information of third parties without their consent, and failure to comply with applicable on-line privacy laws. GetASeedbox.Com will cooperate fully with appropriate law enforcement agencies in connection with any and all illegal activities occurring on or through the Services.

6. Payment Information Prices are in EUR,GBP and RON currency and should be paid in one of this currencies. If paid via PayPal, Moneybookers or AlertPay then these will automatically convert the amount. The Service Provide does not control current exchange rates and therefore exchange rates can vary daily.

7. Cancellation of Services

To cancel account, the customer must login to their account, click on My Hosting Packages, click the service you wish to cancel, and click "Request Cancellation". Cancellation by any other means will not be an acceptable form of a cancellation request.

You will have two options:

- * Immediate: Your seedbox will be terminated within 24 hours. You will not be able to access your seedbox at all.
- * End of Billing month: Your seedbox will be terminated after the billed month.

All cancellation request require 1 week notice in advance if you are not taking your service for the next month. If we do not receive notice within 1 week of your invoice date, we need to suspend your service 3 days before the due date until payment has been made.
